### Benefits of Membership

## Membership Dues

The fee for joining the CAH Coalition is \$5000 a year, to be paid quarterly, or one annual fee of \$4800. Invoices will be emailed to the primary contact for each CAH.

For CAHs in a health system, owned or managed by another company, dues payments are structured as follows:

- 1<sup>st</sup> CAH in a state is \$5000 a year (paid quarterly) or \$4800 in one payment.
- 2<sup>nd</sup> - 5<sup>th</sup> CAH in same state is \$2500 each per year.
- If more than 5 CAHs in a single state, please contact us.
